### **SCHEDULE 1 – Conditions Specific to this Permit**

### 1. Receipt of radioactive waste

- 1.1 You are only authorised to receive the following low level radioactive wastes:
  - a. NORM contaminated components for the purpose of descaling at the authorised place;
  - b. NORM scale received for conditioning and transfer; and
  - c. NORM contaminated wastes, including but not limited to sands, sludges, pig waxes, rags, pig mats, PPE and other ancillary wastes received for the purposes of packaging and transfer.

#### 2. Storage of radioactive waste

- 2.1 You must only store NORM contaminated components or waste for up to one year.
- 2.2 You must ensure that NORM contaminated components awaiting descaling are stored in either the main building or the external storage area.
- 2.3 You must ensure that the final conditioned or packaged waste is only stored in the designated storage area.

### 3. Conditioning of radioactive waste

- 3.1 You are only authorised to condition solid NORM scale waste by mixing it with proprietary cement and process water produced during descaling at the authorised place.
- 3.2 In the event the details of the conditioning process change for any reason, you must forward the revised details to SEPA without delay.
- 3.3 You must ensure that the final conditioned waste form is low level radioactive waste.

### 4. Repackaging of radioactive waste

- 4.1 You must repackage all NORM contaminated waste by removing it from its container in which it arrived and placing it in the designated container for transfer.
- 4.2 You must not add or remove any substance from the NORM contaminated waste prior to, during or after repackaging.
- 4.3 You must carry out the repackaging of the NORM contaminated waste in the designated packaging area.
- 4.4 You must ensure that the final packaged waste form is low level radioactive waste.

## 5. Additional information requirements

- You must submit to SEPA a written summary, for the calendar year, of the following information by 28<sup>th</sup> February of each year:
  - a. The total mass of NORM waste received;
  - b. The volume of NORM waste received;
  - c. The total radioactivity in the NORM waste received expressed as radium-226, radium-228, lead-210, polonium-210 and uranium-238;
  - d. The total mass of heavy metals in the NORM waste received expressed as arsenic, barium, cadmium, chromium, copper, mercury, nickel and zinc; and
  - e. The total mass of petroleum hydrocarbons in the NORM waste received.

### **Interpretation of Terms**

"descaling" means the removal of NORM scale contamination from components using high pressure water jetting.
